Identify gaps, risks, or non-compliance issues during monitoring and promptly report them to the central office for corrective action. Provide basic support and guidance to local partners or project beneficiaries to enhance understanding and adherence to program objectives. Maintain effective communication with the central team, ensuring alignment between field activities and overall program goals.
